Request under the Official Information Act 1982 – Spending on consultant groups

Thank you for your email of 12 March 2024, requesting the following information from Te Pūkenga – New Zealand Institute of Skills and Technology (Te Pūkenga):

- How much money Te Pukenga has spent on consulting groups, like PwC, in 2019, 2020, 2021, 2022, 2023 and 2024 to date.

You kindly clarified your request on 26 March 2024 with the following details:

- 1. I am only interested in the Te Pūkenga National office's spending on consultancy groups, not each business division.
- 2. I am hoping to obtain a breakdown of spending on all consultancy groups since Te Pukenga's creation.

This letter provides a formal decision on your request under the Official Information Act 1982 (OIA).

Interpretation

While you have requested information including 2019, we only hold information since Te Pūkenga establishment (1 April 2020) to date. We have provided information from Te Pūkenga head office consultancy transactions between year 2020 to date, as at 9 April 2024. Please note that our financial year is the same as a calendar year (1 January-31 December). Additionally, 2023 and 2024 information are unaudited and will be finalised in future Annual Reports.

As you did not provide further specifics about which particular consulting groups you were most interested in, noting your reference to PWC, we approached collation for your request by extracting details for the "Big 4" (PWC, EY, KPMG, Deloitte) consultancy firms. We have included BDO and Beca as two further consultancy firms, similar to the "Big 4". We have also extracted information regarding consultants with whom we have spent over \$500K in total over this time period.

The decision

The information you have requested is attached at **Appendix One**. Totals provided are actual payments made, excluding GST.

You have the right to make a complaint to the Ombudsman under section 28(3) of the OIA if you are not happy with this response. Information about how to do this is available at www.ombudsman.parliament.nz or by calling 0800 802 602.

We may publish our OIA responses and the information contained in our reply to you on our website. Before publishing we will remove any personal or identifiable information.
